#### 5. Location

Operational base for the project will be the premises of the MEPP in the Beneficiary country (Macedonia). If/when needed meetings/activities outside the implementation country could take place in accordance with INFORMEST.

#### 6. Main activities and tasks:

The Key Expert will work in coordination with the Resident Twinning Adviser and Project Leader, he/she will have a key role in the activities foreseen in the Component 1 of the project fiche.

#### The main tasks will include:

- Analysis of the administrative capacities for enforcement of environmental law in water, air quality and IPPC/IED (staff, structure, trained experts in specific areas, equipment, documentation, coordination and competences), at central and local level;
- Assessment of the environmental regulatory chain: relations between legislation, permitting, implementation, compliance, enforcement and identification of criticalities in the whole process;
- Assessment and review of environmental inspection system at central and local level based on the
  environmental legislation in force, identifying eventual gaps and additional needs defined by EU
  regulations and its connections with the judiciary system;
- Assessment of system of fines and penalties for environmental violations available for inspectors and judges in charge to enforce existing environmental laws and regulations;
- Provide recommendation to improve the environmental enforcement system in Macedonia based on EU and other of pre-accession countries experiences;
- Provide recommendations for the harmonization of the technical regulations produced within the project and the environmental legislation in force.

## 7. REQUIRED COMPETENCES:

- At least a year work as equivalent staff within departments/units of the institution in charge of environmental enforcement and compliance in a Member State;
- At least a University degree;
- Deep knowledge about EU environmental laws and directives: water, air, pollution, chemical, health and agriculture sectors and excellent understanding of transposition, implementation and/or enforcement of the EU environmental acquis;
- Solid experience in the field of environmental law including robust experience in compliance check and assessment in environmental legislation with the acquis;
- Consulting and research on EU environmental laws as well as their implementation, with particular consideration to the problems related to their enforcement;
- Capacity building of public administration in Accession Countries in assessing and improving the implementation of EU environmental acquis;
- Relevant stakeholder consultation around the implementation of new legislation.

#### 10. SELECTION CRITERIA

The selection criteria is based on the comparison of CVs following the criteria listed in point 7 of the present announcement.

If more than 3 candidates meet the above mentioned criteria an interview will be organized at Informest Headquarters (Gorizia, Italy).

The exact date and time will be communicated directly to the candidates.

The comparative evaluation is under responsibility of a Commission appointed by the RUP and composed by two members and a secretary. The decision of the Commission is incontestable.

At the end of the evaluation, the Commission draws up the ranking of applicants and indicate the selected candidate. If more candidates obtain the same evaluation mark, the precedence is given to the youngest one.

Upon signature the RUP approves the ranking.

In case the selected candidate reject to sign the contract, INFORMEST will scan the ranking.

INFORMEST has the right not to assign the work in case it considers that no applicant fulfill the requested criteria.

The position can be awarded even though just one application is received.
